1. Welcome and Call to Order

- 2. General Public Comment on Non-Agenda Items: two minutes per person (until 7 PM)
 - Stakeholder/WANC Board Member; Jace Dawson; Candidate for CD10 spoke on his credentials, and "bridging the gap,". Asked for individuals to join the campaign
 - Stakeholder Ruth Bieg; resident of Crenshaw Villas spoke on "4.8-5.8" rate increase in rent at the residence. Said Mark Ridley Thomas/Herb Wesson should be present at meetings and address the issue
 - Stakeholder Lucille Thomas (Vineyard Senior Club); Asked about issues with the sidewalk vendors in front of the laundromat at Crenshaw/Adams. Additionally, Hickory/ Palm Grove need a four way stop. Asked for WANC to sponsor senior club event.
 - Stakeholder Marcia Lewis, spoke in support of Holiday Liquor Market. "Has been going for six years." There is a coffee club at Holiday Liquor which Lewis' mother attends. Says the "slander" against Holiday Liquor and the owner are false.
 - Stakeholder, Abduls Sheriff, Owner of Holiday Liquor, spoke on \$2.6 million offer from CIM group "Shaul Kuba," for his properties.
 - Stakeholder, Julie Cain, spoke about her experience with Holiday Liquor and her "drive-by shooting," in which she was involved wheres her vehicle was shot. Provided a listing of the property for "\$4 million...all offers considered." Also said they have 60+ signatures for the case against the property.

- Stakeholder Alfred Torregamo described the September 1st West Adams Block Party, expected to be attended by more than 5,000 people and said he emailed a Neighborhood Purposes Grant application.
- Stakeholder Darrin Dickerson has a public relations firm that works with the community; he said the Block Party has "economic value."
- Stakeholder Ruth League was concerned about the rent increase and believed that a crosswalk is needed at 28th and Crenshaw; many agreed.
- Stakeholder Lucille Thomas was concerned about food vendors and customers blocking sidewalks; believed that a crosswalk is needed at Hickory and Palm Grove; will ask WANC for \$1,000 seniors birthday party funding; and will ask WANC to sponsor the December 17th Senior Citizens Club Christmas event.
- Stakeholder Mia Overstreet was concerned about arrogant bus drivers and believed that a crosswalk is needed at Adams and Clyde Ave
- Stakeholder Dynasty Taylor, of Dynasty's United Youth Association said they "provide free educational, career and mental health services." She thanked WANC for last year's support and reported that they helped many students
- Stakeholder Rev. Odessa McKinsey, spoke about the support for the Holiday Liquor business

3. Administrative Items:

- A. Discussion and possible action on 1st card holder/primary card holder
 - Motion (by Mr. Siroky, seconded by Ms. Overstreet): The West Adams Neighborhood Council appoints Josef Siroky as the 1st card holder/primary card holder.Mr. Burdeos was concerned about Mr. Siroky having a possible conflict of interest. 13 eligible voters present with 12 in favor ("Yes" or "Aye") (Aubry, Curley, Dawson, Graham, Layton, Meeks, Overstreet, Siroky, Thomas, Tootla, Williams and Yancy); one opposed ("No" or "Nay") (Burdeos); zero abstained

B. Discussion and possible action on updated FY 2019-2020 Administrative Summary Packet/ WANC FY 2019-2020 Budget

- Mr. Siroky explained the budget. Almost \$2,000 in rollover funding also was available. The Clean Streets Fund of \$1,200 was separate. Ms. Graham wanted to budget for more Neighborhood Purposes Grants. Mr. Meeks took a straw [unofficial] poll of Board Members regarding Tabling this Item: seven wanted to Table, five were opposed. This Item was TABLED. No Motion was made or vote taken
- C. Discussion and possible action on selection of Community Impact Statement Filers
 - Ms. Graham, Mr. Meeks, Mr. Siroky, Ms. Thomas and Ms. Overstreet volunteered to be Filers. The West Adams Neighborhood Council approves Leslie Graham, Steven Meeks, Josef Siroky, Connye Thomas and Yolanda Davis Overstreet to become the WANC Community Impact Statement Filers. Unanimously by a voice vote; zero opposed; zero abstained
