- #5. Senior Lead Officer, LAPD Officer Mejia was not available; however, Leslie Graham who attended the Community Police Advisory Board (CPAB) provided the following:
  - a. Robberies were down;
  - b. Watch for incidents on the train platforms, buses from the rear-
- c. The message: Be Vigilant and engage in Vigilance and be cognizant of your surroundings; LAPD is a presence now on the trains and MTA buses
- #6. Councilmember Herb Wesson's CD 10 Update: Mr. Kimani Black-Mr. Black discussed
  - a. Rodeo Road will be renamed "Obama Road."

- e. A "Hope Team" comprised of LAPD, sanitation and other agencies will be deployed to and for clean-up at homeless shelters
  - f. Mr. Black opened the floor for interaction and discussion with WANC stakeholders:
    - i. Stakeholders discussed traffic issues
- ii. Stakeholders had concerns over a parked motor home in the West-Adams neighborhood-Mr. Black stated that the parked motor home if parked in a "green zone" was legal; however, Mr. Black indicated that if stakeholders had further concerns to contact him directly
- g. Finally, Mr. Black advised the WANC Board and the stakeholders that CD 10 has opposed the real estate development located at 4011 Exposition Boulevard.
- #7. Department of Neighborhood Empowerment (DONE): Mr. Brett Shears-emphasized
  - a. On-line voting for WANC elections June 2019
  - b. WANC is one of other neighborhood councils for on-line voting
  - c. Voting is scheduled for Thursday/Saturday
  - d. Bridge housing-could have approximately 222 beds along with multiple sites
  - e. Neighborhood councils Bylaws changes are posted on the website
- f. Mr. Shears emphasized the September 22, 2018 Neighborhood Councils Congress (NCC) slated for bustling and informative activities at City Hall starting at 7:30 am

- #9. Standing Committee and City Liaison Reports:

There was no City Liaison Report, but Mr. Meeks provided this information on standing committees:

- 1. Land Use-no report
- 2. Outreach: there is a scheduled workshop on the new law-the City of Los Angeles enacted and signed ordinance permitting accessory dwelling units (ADU's) in the ambit of the City of Los Angeles; said workshop is tentatively scheduled for October 30, 2018
- a. Another planned outreach workshop on "Tenants Rights" is scheduled after the November election-around late November or early December 2018
  - b. Outreach and the general elections is moreover being addressed
  - c. The WANC Resiliency Workshop as well
- 3. Safety: WANC Board member Elbert Preston advised that if anybody, a stakeholder, a WANC Board member were to put in there zip code into the LAPD website for crime statistics and crime locations, you can locate those stats and crimes

#10: Presentation by 7-Eleven Proposed Development at 3407 Crenshaw Boulevard-this location is within the ambit of the WANC coverage; however,

WANC Board member Leon raised a multitude of concerns regarding the need for or of having another 7-Eleven; one, concerns over hiring/employment practices, two, increase in traffic/vehicular and pedestrian flows in an already heavily trafficked area, three, cost of franchises-is ginormous; thus the cost to our stakeholders to purchase 7-Eleven items/products will be nigh-unaffordable, four, 7-Eleven is not convenient, five, the benefit is non-existent, six, safety is a huge factor; seven, there are other near-by 7-Elevens within a proximate area of one to two miles; WANC Board member Clint raised safety concerns as well; WANC Board member Adam also had concerns over 7-Eleven; WANC Board member Coach raised problems with 7-Eleven; A stakeholder had issues with 7-Eleven as well; however, per Eva Aubrey, the Land Use Committee approved the project.

#### New Business:

#11a. This item contained statements made by stakeholder Connie relative to the Baldwin Hills Homeowners Association (BHHOA) not receiving the \$1500.00 that they-BHHOA-felt they-BHHOA should have received. WANC Board member Coach offered the fact that the funding office had rejected the payment request-the Board Action Certificate (BAC)

Steven Meeks interjected that perhaps the WANC documentation submitted to DONE was untimely. BHHOA-Connie was concerned regarding the \$1500.00 payment; perhaps DONE or funding could respond.

#11g. neighborhood Purpose Grant (NPG) Presentation by Holly Fuller of the Concerned Black Men of Los Angeles also known as "Welcome to Womanhood" program that will improve a girl's self-esteem, financial literacy, college prep, personal hygiene, etc.; however, this program is outside of WANC's coverage. Subsequent to that opening, WANC Board member Leon voiced concerns over the need for "Welcome to Womanhood" program. Other WANC Board members, Clint, also voiced concerns. Steven Meeks stated that because "Welcome to Womanhood" program is beyond the boundaries of WANC so "Welcome to Womanhood" program should seek a NPG application in a more suitable neighborhood council boundary. So, discussion was closed.
