

SB 411 Updates:

If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a



disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

While the members of the West Adams Neighborhood Council appreciate the well-meaning intent of the motion referenced by Council Files 15-0389-S2 and 15-0389-S1, granting Community Councils the same privileges as those afforded to Neighborhood Councils pursuant to Los Angeles Administrative Code Section 22.819, West Adams Neighborhood Council must oppose the motion for the following reasons:

All certified Neighborhood Councils are required to comply with the Brown Act, Public Records Act, relevant City ordinances, and the policies and rules of the Board of Neighborhood Commissioners, Department of Neighborhood Empowerment, and the City Clerk's Neighborhood Council Funding Program and Election Division, including several training, funding, and records requirements. In contrast, community councils are not subject to these requirements, which serve to promote transparency, accountability, and public participation.

Neighborhood Councils are prohibited from activities such as raising outside funding, supporting or opposing candidates and ballot measures, and suing the city. Depending on their status Community Councils may support candidates and ballot measures. Community Councils can restrict board membership in any way they choose, do not need to give notice of meeting times and locations, do not have to allow the public to attend and address them, or let the public know what they are discussing and deciding. The purpose of the Neighborhood Council System is supposed to be open discussion of issues in a public meeting. Community Councils can meet and decide issues in ways that are opaque and secretive. Several years ago, the Pacific Palisades Community Council declined to seek Neighborhood Council status, stating it did not wish to comply with the Brown Act and other laws. It also solicits private contributions, which Neighborhood Councils are not allowed to accept. The Brentwood Community Council requires the annual payment of \$150 by each person serving on its Board, contrary to the City ordinance governing Neighborhood Councils. The Westwood Community



Council, while unnamed in this motion, operates with "annual voluntary dues" and "contributions," which Neighborhood Councils are again not allowed to accept. It also exists in an area already covered by two certified Neighborhood Councils, (the North Westwood Neighborhood Council and the Westwood Neighborhood Council). If this motion is implemented, this both could provide an unfair advantage to one community (of double speaking time, CIS filing, etc.) that is not available anywhere else in the City and could also muddle the stance of our area when there are disagreements.

Further, if this motion is adopted by the City Council, it will mean that other Community Councils, Civic organizations and possibly Homeowners organizations throughout the city can demand the same privileges. Will the Council next permit Homeowners Associations and Condo Associations the same rights as Neighborhood Councils? Residents Associations? Chambers of Commerce?

Instead of providing special treatment of community councils (and opening a Pandora's box of who else gets recognized), the City Council should instead instruct the Department of Neighborhood Empowerment to prioritize the formation of Neighborhood Councils in community council areas where Neighborhood Councils do not now exist, and to facilitate participation by Community Councils in areas where Neighborhood Councils already exist. Further, if the City Council is concerned with hearing from Neighborhood Council and community voices, it should reinstate telephonic comment at committee meetings and make Neighborhood Council comment separate from public comment. Additionally, the City Council should address the movement of general comment to the end of the agenda, which was done in contradiction of Council rules and without debate or discussion.

The West Adams Neighborhood Council supports Council File 24-0995, which proposes to instruct the Bureau of Sanitation (BOS), with the assistance of the Ratepayer Advocate (funded by BOS), to conduct a supplementary review of the proposed Sewer Service Charge rate adjustments and the components that comprise it - consisting of the capital program, operation and maintenance expenses and debt service requirements - in order to assess its viability and



determine if there are alternative methods to address the wastewater system's challenges thereby protecting the interests of the ratepayers. (Motion by Council member Monica Rodriguez) In addition, two outreach events conducted by the Bureau of Sanitation to educate over 3,000,000 residents in Los Angeles about the proposed adjustments that will greatly impact their economy is simply insufficient. West Adams Neighborhood Council recommends more outreach be done.

The West Adams Neighborhood Council is opposed to the proposed increase in Sewer Service Charge. The increase, as proposed, 22% in 2024, and approximately 120% total by 2028 will be detrimental to the cost of living for residents and businesses of Los Angeles who are already struggling to make ends meet. The cost of living in Los Angeles is already too high. Lack of planning and foresight on the part of the Bureau of Sanitation should not adversely burden the citizens of Los Angeles. Therefore, SVANC supports CF 20-0995 and requests that more public outreach be done.

The West Adams Neighborhood Council supports CF 24-0602. The West Adams NC requests that the report requested from the Chief Legislative Office and the CAO office be unbiased, weighing the pros and cons of using artificial turf to replace grass in residential areas. The West Adams NC expects that in the report is an analysis of the costs, environmental hazards, and human health consequences of artificial turf installations containing polyfluoroalkyl substances, or PFAS in Los Angeles. If the report shows that current installations of artificial turf are detrimental, then that the City Council ban the use of artificial turf for residential purposes in the City of Los Angeles per SB676 passed in 2023.



WANC Subcommittee Three letters of request to LADOT

<u>Letter #1 - Traffic Safety Study Jefferson Blvd</u>

Jefferson Boulevard, identified by LADOT's High Injury Network (HIN) as one of the deadliest streets in the City, continues to pose major safety and mobility concerns to our community members. Already this year, there have been at least three pedestrian and cyclist deaths along the stretch of this boulevard that runs through our neighborhood council district boundaries. Therefore, the West Adams Neighborhood Council (WANC) would like to request that LADOT do a comprehensive Safety Study on the section of Jefferson Boulevard between La Cienega Blvd. and Crenshaw Blvd. and report back within 180 days on a list of potential safety improvements. Specifically, WANC is requesting that the Safety Study also include a list of quick-build safety improvements that can be implemented within 6 months.

Letter #2 - Bike Lane Feasibility Request for Exposition Blvd

Exposition Boulevard is a popular route in our community for cyclists that lacks comprehensive cycling safety infrastructure and is plagued by speeding automobiles and non-attentive drivers. Therefore, the West Adams Neighborhood Council (WANC) would like to request that LADOT do a feasibility study on creating a parking-protected bike lane on Exposition Boulevard between Crenshaw Blvd. and La Brea Blvd - similar to what exists on Venice Blvd and San Vicente Blvd. and other streets in CD-10.

Letter #3 - Update on Speed Camera Program Implementation

In November of 2023, the West Adams Neighborhood Council (WANC) submitted a letter of support to LADOT General Manager Laura Rubio-Cornejo for the Speed Camera Pilot Program. Our letter in 2023 noted the urgent need for this program and requested swift implementation of this important traffic-safety tool in our community. Please accept this letter as a formal request for a comprehensive update on the progress of this program in our community, including a timeline for when the program will go live.



WANC Public Safety Committee COMMUNITY IMPACT STATEMENT

Regarding: Council District 10's TraU'ic Safety Plan

Position: Against

The West Adams Neighborhood Council (WANC) is against the TraUic Safety plan presented to the WANC Safety Committee by Council District OUice10 as it lacks urgency, has no comprehensive strategy, and is grossly inadequate to address the traUic safety concerns that have been raised to this oUice. TraUic violence is one of the most serious threats to public safety in Los Angeles. In 2023, there were 336 traUic fatalities in the City, the most in more than 20 years. Disturbingly, more than half of those deaths were our most vulnerable road users: pedestrians and cyclists. In Council District 10 alone there were 895 total traUic collisions reported last year, according to LAPD records. Los Angeles traUic deaths for 2024 are currently projected to exceed the 2023 totals. The West Adams Neighborhood Council community is particularly vulnerable to the threat of traUic violence as our district is transected by some of the most dangerous streets in the City as identified by LADOT's High Injury Network (HIN): W. Adams Blvd, JeU'erson Blvd, La Brea Ave, Crenshaw Blvd, Obama Blvd, S. La Cienega Blvd, and Farmdale Ave. WANC submitted a formal request to Council District OU'ice 10 in April of 2024 requesting a report, within 60 days, about CD 10's plan to combat rising traUic violence in our community. The request noted that a "comprehensive strategy and timely implementation of traUic safety measures in partnership with your OUice, LADOT, LAPD, and other City agencies is urgently needed." The "plan" returned back to WANC, after more than 100 days, had only three (3) future traUic safety installations for our entire neighborhood council district, including: one left-turn phasing, one all way stop, and one pedestrian hybrid beacon. The traUic safety plan from Councilmember Hutt's oUice is not data-driven and it lacks input from, or coordination with, LAPD, LADOT, and other City agencies. The lack of priority, and the unwillingness to lead on this critical issue from the Council District, is continuing to have adverse impacts on the health, safety, and mobility of our community.
