Summary of Motions Introduced (*New Legislation*)

Council File 25-1461, Pre-qualified Unarmed Crisis Response Contractors / Procurement / Unarmed Model of Crisis Response (UMCR) (Blumenfield - Hernandez - Harris-Dawson)

Introduced December 5, 2025, and referred to Council. The Motion authorizes the City Administrative Officer (CAO) to initiate a procurement process to establish a five-year bench of pre-qualified unarmed crisis response contractors, including the needed systems and infrastructure.

Introduced December 2, 2025, and referred to the Budget and Finance Committee and to the Public Safety Committee. Public Safety Committee scheduled item for committee meeting on December 10, 2025. The Motion is instructing the City Administrative Officer (CAO) and the Chief Legislative Analyst (CLA), with the assistance of the City Attorney and all relevant departments, to develop and report back on a permanent City policy for fee waivers for disaster-impacted residents, including those affected by wildfires, floods, earthquakes, and other declared emergencies.
