Council File 25-1328, Human Trafficking Task Forces / Operations - South Bureau and Operations - Valley Bureaus / Rescues of Trafficked Individuals / Status Update (Padilla - Lee)

Introduced November 7, 2025, and referred to the Public Safety Committee. The Motion is instructing the Police Department to report with a status update and an overview of the work done the Operations - South Bureau and Operations - Valley Bureau Human Trafficking Task Forces over the last five years, including the number of arrests made annually and the number of rescues of trafficked individuals made by the Department.

The Motion is instructing the Los Angeles Police Department (LAPD) to create a public campaign proposal to promote how Press can obtain an LAPD press badge. The proposal should also include potential funding sources within LAPD's budget.

Introduced November 5, 2025, and referred to the Public Safety Committee. The Motion is requesting that the City Attorney draft an ordinance that allow defined members of the media to access defined areas of a protest that are closed to the public; expands the definition of a journalist to recognize new forms of media that may not be a "duly authorized representative" of a formal news organization; and that establishes penalties for people who gain access to a restricted area by claiming privileges and then engage in protest activities.
